PART B: PAYMENT PERIOD AND CURRENCY

- 1. Tuition fees will be invoiced before each semester or term starts.
- 2. Please make all payments in US Dollars and include a note detailing which invoices you are paying, as well as your child's code.
 - *Payment may be made in the following ways:
 - (a) Cash payments are not accepted for any school fees.
 - (b) Payments will be accepted by bank transfer or cheque only.
 - (c) Payments can be made by Wing Mobile App, J Trust Royal Bank Mobile App and ABA Mobile App.
- 3. If payment is made in Khmer Riel (KHR), the exchange rate is USD 1.00 = KHR 4100.
- 4. Bank transfer fees incurred by SISC are charged to your account.

PART C: ADMINISTRATION FEE POLICY

- 1. The registration fee is a one-time fee for new students in years ranging from Nursery to Year 13. This non-refundable and non-transferable fee must be paid in full by the 1st payment date to ensure your child can start school.
- 2. Tuition fees are non-refundable and non-transferable. These are payable from the start date, pro-rated based on the number of school days. Students who start within 10 days of the beginning of the semester are required to pay the full tuition fee.
- 3. The capital fee is a fee required for all students, including new and returning students, to cover the cost of maintaining and upgrading the SISC campus, facilities, technology and learning resources.
- 4. The full capital fee will be invoiced if the students enrol between July and December, or half of the capital fee will be invoiced if the students enrol between January and June.
- 5. Capital fee must be paid in full on the 1st payment date and this fee is non-refundable and non-transferable if the student withdraws throughout the academic year.

- 1. <u>Due Date:</u> payments must be submitted on or before the deadline to avoid any late fees.
